The Riverside Branch of AAUW will be holding its annual meeting on April 20<sup>th</sup>. It is my hope that we can get a good turnout from our members as we will be

voting on a number of items and be hearing from a dynamic speaker, Joan Donahue, President of the League of Women Voters.

In addition to voting on the officers who will guide us next year, we will also be voting on the budget for fiscal year 2012-13 and amendments to the Bylaws. The slate of officers recommended by the Nominating Committee appears in this Pipeline. Nominations may be made from the floor at the Annual Meeting with the consent of the proposed nominee. The proposed budget and amendments to the Bylaws will be sent out under separate cover. In addition to the changes to the Bylaws mandated by the National AAUW, other changes will be recommended to update the Bylaws and address the issue of succession.

Joan Donahue will be speaking on Income Inequality - How did it get so bad and what can we do to fix it? There has been a growing income disparity between the wealthy and the middle class, but the reality of the phenomenon was left undefined or swept under the rug until recently. In 2011, with the emergence of the Occupy movement's 99 percenters and staggering new statistics from the Congressional Budget Office, the issue has come to the forefront.

This is an issue which needs to be discussed by organizations such as AAUW. AAUW advances equity for women and girls. Income and its growing disparity between the 1% and the 99% or the wealthy and the middle class touches on this mission and the future of our country. Come and join the discussion.

## EQUAL PAY DAY

Another year, another 23-cent wage gap for women and their families.

And with our inactive Congress and still-troubling economy, women feel the pinch of the wage gap even more, but there's little being done about it.

That's where you come in.

**We invite you to mark Equal Pay Day, Tuesday, April 17, and spread the word about the gender pay gap and AAUW to everyone you meet. Tell them :**

- Women on the average earn 77 cents for every dollar that a man earns.
- Just one year after college graduation, women make only 80 percent of what their male counterparts earn.
- *The Paycheck Fairness Act* is a bill that's before congress and deals with pay equity, but members of Congress need to hear you support it!
- Pay attention to the elections, and ask local candidates running for office what they'll do for California's wage gap.

## VOTING

We will not vote at State Convention this year, although we still may nominate candidates from the floor and submit resolutions.

In early May, every member will receive an email from AAUW CA with an access code and a link to vote. Members who do not have email or whose email "bounces" will receive a postcard with this information. Every member will have the opportunity to vote, either online or by submitting a paper ballot

**ALL VOTING WILL END ON JUNE 1 AT 9:00 P.M.** The results of the election will be available on the CA website within a day or so.

## HARASSMENT UNDER REPORTED

AAUW [released an analysis](#) of the new data from the U.S. Department of Education that shows a remarkable disparity between what school district administrators are reporting and what students say is happening at their schools.

The eagerly awaited Civil Rights Data Collection (CRDC) data from the 2009–10 school year includes, for the first time ever, information on harassment and bullying — a move AAUW applauds.

But, according to AAUW's analysis, 14 of the 20 largest school districts in the nation (including Los Angeles) reported **no incidences of bullying or harassment**. Specifically, the schools did not report allegations of sexual harassment, disciplinary actions as a result of bullying or harassment on the basis of sex, or students who reported being bullied or harassed on the basis of sex. These numbers fly in the face of reputable research and common sense.

"These reports of no sexual harassment and bullying happening in a school district are impossible to believe," said AAUW Executive Director Linda D. Hallman, CAE. "It just does not sync with what we know to be the unfortunate reality for many school children in this nation. High-profile incidents in the press of students being bullied to death and independent research conducted by AAUW shows that it is highly unlikely that any school district would be free of sexual harassment and bullying." ## EDUCATIONAL FUNDS

Did you know that AAUW granted its first fellowship in 1888? More than a century ago Vassar graduate, Ida Street, studying early American Indian history received a grant for \$350 to pursue her graduate studies at the University of Michigan. AAUW has now topped \$80 million in grants to more than 11,000 women and this year 240 Fellowships were granted.

Did you know that last year, AAUW awarded over 3.7 million dollars in Graduate Fellowships and Awards and is one of the world's largest sources of funding for graduate women? And gave over 1 million dollars in scholarships and awards to undergraduate students last year?

Do you know how all this happens? Suppose I win the lottery and set up a \$200,000.00 Riverside Branch Fellowship Fund. At the end of a year, the fund will have earned, maybe, \$10,000.00. That is not enough to give a \$18,000.00 to \$30,000.00 Fellowship. But the earnings from the Riverside Fund and another Fund or two would be enough to pay for a Fellowship.

Funds can be from \$75,000 to \$200,000, but none of the interest money can be used until the full amount of the Fund is achieved. It's common to hear about "unfunded" funds as those are the ones that haven't reached their goal. There are presently 215 + completed funds and there are still many others that are unfunded.

These are the different types of Fellowships and Awards that are given:

- American Fellowships
- International Fellowships
- Selected Professions Fellowships
- Research & Projects Community Action Grants
- Research & Projects Career Development Grants

How are the Fellowship and Grants determined? There are panels established to go through all the applicants (and there are usually two or three times as many applicants as there are moneys to be awarded). There is a separate panel for each of the types of Fellowships and Grants that are offered. The panelists serve two years so half of each panel is selected each year.

Scholarships operate a little bit differently. Suppose I decided to set up a \$200,000.00 Riverside Scholarship Fund. Again, at the end of the year, it might earn \$10,000.00 and that would be enough for the Riverside Branch to award a scholarship to some deserving undergraduate candidate of our choice. If the Fund earned less, the scholarship would be for less. If the Fund earned more, we might decide to award two scholarships.

## AAUW SUPPORTS SECOND MILITARY SEXUAL ASSAULT CASE

On March 6, eight current and former service members [filed a lawsuit](#) against U.S. Secretary of Defense Leon Panetta and numerous Marine Corps officers. The plaintiffs are accusing military officials of creating a culture in which sexual assault and rape is tolerated and in which people who report it face retaliation. AAUW is providing support to this case and to [Cioca v. Rumsfeld](#), which also deals with the issue of sexual assault in the military. The new case focuses on assault and harassment in the U.S. Marine Barracks in Washington, D.C. Lawyer Susan Burke plans to file additional lawsuits focused on similar crimes in other branches of the military. AAUW Executive Director Linda Hallman spoke at the March 6 press conference and emphasized that AAUW would stand with these courageous women as they work to create a safer environment for women in the military.
