

RECENT SUPREME COURT RULINGS

The Supreme Court [stayed](#) the appeals court ruling that reinstated same-day registration and out-of-precinct voting by provisional ballot in North Carolina. The court's order, which did not explain the justices' reasoning, means that these harmful voting restrictions will be in effect for the upcoming midterm elections.

Yet the next day, the Supreme Court [stopped](#) the implementation of Wisconsin's voter identification law. Again, the order did not explain the justices' reasoning, but experts theorize that the court may have stopped implementation in Wisconsin because absentee voting had already begun without the identification requirement. Also that day, a federal district judge struck down a strict voting law in Texas that could have prevented an estimated 1.2 million eligible Texans from voting in the upcoming election. Texas is expected to appeal the district court ruling.

Last week, the U.S. Supreme Court [suspended](#) an October 2nd appeals court ruling that had allowed an extreme Texas anti-abortion law to be in effect. This order means that more than a dozen clinics in Texas no longer face the threat of shutting down. The Fifth Circuit Court of Appeals is still considering the constitutionality of the law, which has already forced [half of the state's abortion clinics](#) to close since the law's implementation began in November 2013.
