## **Riverside AAUW Tech Trek Brunch**

The Riverside Branch of AAUW assembled on Saturday, September 13, at 10:00 AM in the multi-purpose room of the Altura Credit Union, 2347 Campus Way, Riverside. This is a special occasion, a Brunch, to honor the nine girls going into eighth grade, -- two from Moreno Valley Unified, and seven from Riverside Unified School District (RUSD), who have attended AAUW's one week summer camps where they studied science, technology, math and engineering. The Riverside students went to Whittier College and the Moreno Valley students to UC San Diego.

President, Barb Ryon, graciously welcomed everyone – the Tech Trek girls, their parents and siblings, and members. She was pleased to note that both Superintendant, Dr. Judy White and Assistant Supt., Dr. Martinrex Kedziora, from Moreno Valley Unified School District (MVUSD) were present to hear these special students.

President Ryon asked that we delay partaking of the delicious food at the buffet to hear one Tech Trek girl who had to leave early. Lisa Newhall, Co-coordinator for RUSD Tech Trek, called <u>Marisil Chavez</u>, from Central Middle School, to share some of her experiences at Whittier College. Marisil found living in a dorm "fun" and learning to "analyze" a useful skill. She knows that she "can do whatever she puts her mind to". She has had much experience in playing different musical instruments and is most interested in "band", but is not sure where she wants to attend college.

President Ryon invited everyone to go up and survey the smorgasbord and try the different foods provided by the Riverside Branch under the supervision of Barbara Purvis, Program VP.

Again, Lisa Newhall, Co-cordinator of Tech Trek, summoned each girl, one at a time, to come forth and share their experiences and favorite activities. <u>Lia Villarreal</u>, from Central Middle School, RUSD, went to Whittier College and found her favorite thing was building a Lego robot which they activated via the computer. Lia loved the sea trip and also loved being independent.

Christine Morgando is the Co-coordinator for MVUSC. <u>Jaylene Slack</u>, from Palm Middle School, went to UC San Diego, and enjoyed the anatomy class because they dissected a cow's heart – most like a human heart. She also made a bridge using coffee stirrers and guests got to check it out. She didn't indicate what her college choice would be, but she has had a taste of biology and engineering.

<u>Stacy Sweitzer</u>, Palm Middle School, MVUSD, went to UC San Diego also, engaged in a chemistry experiment which demonstrated how plants excrete carbon dioxide. (She passed around the example for guests to try.) She's most interested in being a computer engineer – how text messages are turned into 0's and 1's. She said she learned that "hard work gets you where you want to go".

<u>Carmen Sanchez</u>, from Gage Middle School, RUSD, feels this experience changed her life. One of her favorite classes was "Mars Alpha" -- designing the first city on Mars. She's decided to be in the designing world when she chooses her life work.

<u>Nicole Skaggs</u>, from Earhart Middle School, RUSD, had a core class in anatomy and was able to visit a medical school near the campus and view the cadavars kept in a lab -- one especially of a woman who had died of cancer. This was all interesting to her, e.g. analyzing the size of a bone and relating it to a person. She hopes to go into forensics.

As can be noted, only six of the nine Tech Trek students were present at this Brunch, the others were unable to attend. All of the students present here this day thanked AAUW profusely and considered this experience at a real college to be positive and enlightening. They had gained both academically as well as socially and in independence – which, hopefully, leads to greater self esteem. The Riverside Branch is proud of this Tech Trek program and plans to continue it. Funds raised today will be used to provide funds for next year's summer camp. Dr. Judy White considers it such a learning experience that they plan to send five girls next year from MVUSD. They have received a special grant to fund them.

Jo Turner, Publications Chair, was quietly selling raffle tickets to any and all for a chance to win an afghan, hand crocheted by Member, Ginger Martin. (This is another way that we raise funds for Tech Trek.) Dr. White was chosen to pick the name of the "lucky winner" out of the hat. Dr. White warned us that, if she drew her own name, she would keep the afghan because she is expecting a grandchild. Dr. White picked a name—that of Member Ruth Wilson. Ruth promptly gifted the afghan to Dr. White for her coming grandchild. What a positive way to end a wonderful day.

President, Barb Ryon, thanked everyone for coming, for their contributions, and to Barbara Purvis, Program VP, and her willing crew, for the delicious food. The meeting was adjourned.

## **PUBLIC POLICY**

Six statewide ballot propositions are certified for the November 2014 ballot in California. Here is a short description of five of them, and the position AAUW-CA recommends:

**Proposition 1 - \$7.12 billion bond for California's water system.** Put on the ballot by the California Legislature, this measure would authorize the sale of \$7,120,000,000 in state bonds, and reallocate \$425,000,000 of unissued bonds to finance the purpose of water quality, supply and infrastructure improvements. AAUW CA supports the passage of this initiative.

**Proposition 2 - State Budget. Budget Stabilization Account. Legislative Constitutional Amendment.** This proposition requires the state to spend a minimum amount each year to pay down specified debts. It creates a Public School System Stabilization Account (PSSSA) which is funded by a transfer of capital gains-related tax funds in excess of 8% of the general fund revenues. It creates rules about forecasting estimates of revenues and expenditures for 3 fiscal years with 1.5% annual deposit of general fund revenues and taxes from capital gains in excess of 8%, and changes rules for taking money out of the BSA. Funds would be appropriated when state support for K-14 education exceeds the allocated revenues and resources. School districts will be limited in the amount of reserves that can be kept at the local level. While theoretically the PSSSA is a positive step for education, an analysis by Ed Source (of which AAUW CA was a founding partner) states the PSSSA would not likely be funded until the end of the decade. With this degree of uncertainty, AAUW CA remains **neutral on this proposition.** 

**Proposition 45 - Public notice required for insurance company rates initiative.** This initiative would require the Insurance Commissioner's approval before a health insurer could change its rates or anything else affecting the charges associated with health insurance. It provides for public notice, disclosure, and hearing, and subsequent judicial review, and exempts employer large group health plans. AAUW CA recommends an oppose position on Proposition 45.

**Prop 46 - Drug and Alcohol Testing of Doctors. Medical Negligence Lawsuits.** This proposition implements measures to reduce doctor impairment from drug and alcohol use. It would require health care practitioners to consult state prescription drug history database before prescribing certain controlled substances. Finally, it would increase the cap on pain and suffering damages in medical negligence lawsuits from \$250,000 to over \$1 million, reflecting inflation. Because AAUW supports access to quality, affordable health, it opposes this initiative and recommends a NO vote.

**Prop 47 - Criminal Sentences. Misdemeanor Penalties.** The initiative would reduce the penalty for most nonviolent crimes from a felony to a misdemeanor. Specifically, the initiative would mandate misdemeanors instead of felonies for "non-serious, non-violent crimes," such as petty theft and drug possession, unless the defendant has prior convictions for violent and serious crimes. AAUW CA recommends a *support* position on this initiative.

**Prop 48 - Ratification of gaming compacts.** AAUW CA did not study this initiative, as it is not related to the AAUW CA Public Policy Priorities.

It pokes fun and yet loves its characters for struggling to cope with a difficult world - the present.



Gordimer's prose is dense, verbose, paying no attention to grammar and syntax, sentences often a paragraph long, and the reader has to excavate the important material the novel contains. But she writes with compassion and perspicuity which brings her readers to tears—the complexities and agony of that tortured land, both primitive, in one sense and first world, in another.
